Dear Republican Friend,

Pursuant to the provisions of Minnesota Statutes and the Constitution of the House District 42A Republicans, the precinct caucuses for Arden Hills Precincts 1, 2, 3; Mounds View Precincts 1, 2, 3, 4; Shoreview Precincts 3, 4, 5, 6; Spring Lake Park Precinct 1R; and Blaine, Ward 1, Precinct 9, are to convene on **Tuesday, March 1, 2016**, promptly at 7:00 pm at:

**Chippewa Middle School
5000 Hodgson Road
North Oaks, MN**

You can find your precinct number at hd42agop.com/votinginformation or mnvotesinfo.sos.state.mn.us/voters/precinct-caucus. Please **arrive between 6:00 and 6:30 pm** to register because **there will be speakers before the precinct caucuses convene at 7:00 pm to conduct their official business.** In addition to the school's parking lot, parking will be available across the street from the school at Hope Christian Church (entrance via Hodgson Road Connection) and directly south of the school at Incarnation Lutheran Church.

The caucuses shall be held for the purpose of:

1. Election of precinct officers. There is space on next page to fill in names of those elected.
2. Election of 130 delegates and 130 alternates to the House District 42A and Senate District 42 conventions to be held April 2, 2016, at Chippewa Middle School. There is space on next page to fill in names of those elected.
3. Discussion of candidates, issues, and party resolutions.
4. Casting of Presidential preference ballot (also known as "straw poll"). The valid votes cast in the straw poll, as totaled within US Congressional District 4 and statewide, will be the basis for proportional allocation of national convention delegates and ranked alternates bound to Presidential candidates on the first ballot at the national convention. The statutory rules governing the caucuses are found in Minnesota Statutes sections 202A.14 through 202A.20 and include the following:

1. Precinct caucuses must remain open for at least one hour.
2. Nominations for election of permanent officers of the precinct and delegates and alternates shall remain open for at least the first 15 minutes. They may remain open longer.
3. Election of delegates and alternates may begin 30 minutes after convening the caucus, but must begin within one hour of convening the caucus. There is no set time to finish.
4. All voting shall be by secret ballot. Minnesota law requires a secret ballot.
